WHEREAS, the Borough received five (5) bids, opened and read on July 29, 2010, for the performance of Garden Debris, Recycling & Solid Waste removal and disposal; and

WHEREAS, the Chief Financial Officer has certified as to the availability of funds for this award.

NOW, THEREFORE, BE IT RESOLVED, that the bid for the Curbside Collection, Removal, Transportation, and Disposal of Solid Waste, Contract No. 2010-103, be awarded as follows:

1. Solid Waste awarded to Interstate Waste for a 5 (five) year period commencing December 1, 2010 and terminating November 30, 2015 in the total amount of \$3,678,659.

Recycling awarded to Advanced Waste for a 3 (three) year period commencing December 1, 2010 and terminating November 30, 2013 in the total amount of \$329,960.

Garden Debris awarded to Advanced Waste for a 5 (five) year period commencing December 1, 2010 and terminating November 30, 2015 in the total amount of \$164,620.
2. The Mayor and Borough Clerk are hereby authorized to execute the Contract and take all actions necessary or convenient to facilitate the implementation of services pursuant to this Contract on December 1, 2010.
3. The Municipal Manager, the Borough Attorney, Engineer and Borough staff are all hereby authorized to take all actions necessary or convenient to facilitate the implementation of services pursuant to this Contract on December 1, 2010.

4. Upon satisfaction of the requirements of N.J.S.A. 40A:11-24(a), the bid security shall be returned to the remaining unsuccessful bidders.
5. This Resolution shall take effect as provided by law.
